7-2 The Governance Structure of IRP

IRP currently consists of 12* governments, UN agencies and international organizations including ADRC (as of March 2008). IRP focuses on the following three functions as priority activities on recovery that are respectively based in Kobe, Turin, and Geneva: a) Knowledge Management and Adovocacy (Kobe), b) Training and Capacity Building (Turin), and c) Enhanicing Recovery Operations (Geneva).

As described in the Terms of Reference, IRP Kobe bears the Secretariat function and is responsible for convening the IRP steering committee meetings as well as disseminating IRP activities and outcomes.

7-3 Activities of IRP in 2006

7-3-1. IRP Side Event in the Global Platform for Disaster Risk Reduction

During the First Session of the Global Platform for Disaster Risk Reduction (GP/DRR) held on 5-7 June 2007 in Geneva, IRP Secretariat in cooperation with ADRC, organized a side event together with the government of Japan and the UN/ISDR Secretariat, which focused on ways to contribute to



better disaster recovery. It was attended by about 80 people from IRP partners, ADRC,

international & regional institutions, governments, and NGOs.

H.E. Mr. Makio Miyagawa, Ambassador to the Permanent Mission of Japan to the

UN in Geneva, delivered the opening address. He spoke not only about Japan's

contributions to international disaster cooperation efforts aimed at promoting the HFA but

also about the achievements of the IRP, such as its organization of the International Forum

on Tsunami and Earthquake, its development of recovery support tools, and its launch of

the earthquake disaster risk reduction project for the South Asian Association for Regional

Cooperation (SAARC). Many participants expressed great expectations for the IRP's role

in facilitating a smooth transition from emergency response, rehabilitation, and

reconstruction through long-term recovery. Furthermore, Mr. Satoru Nishikawa, then

Director for Disaster Preparedness, Public Relations and International Cooperation in the

Cabinet Office of Japan noted that the IRP is expected to function as a catalyst for better

recovery by creating and sharing expertise and know-how with relevant institutions and

persons in need of such information. He concluded the meeting by expressing the need to

further promote these activities to avoid making the mistakes of the past and to work with

stakeholders to contribute to sustainable development.

Also at the plenary meeting on the last morning of the event, Mr. Anil K. Sinha,

Program Advisor of IRP gave a briefing on the IRP's main activities since its

7-3-2. Regional Recovery Forum at the Second Asian Ministerial Conference on Disaster Risk Reduction

The Second Asian Ministerial Conference on Disaster Risk Reduction was organized in New Delhi, India on 7 - 8 November. The conference, following



the Beijing conference in September 2005, aimed to review the Asian countries' efforts to implement the Hyogo Framework for Action (HFA) which was adopted at the WCDR 2005 in Kobe.

Some 500 people attended, including ministers and cabinet-level officials charge of disaster management from across Asia, as well as representatives from the UN, regional organizations, academic institutions, and NGOs from about 50 countries. They eagerly discussed disaster management activities in Asia at high-level round tables, technical sessions, and side events. On the second day of the conference, the



Delhi Declaration 2007 was adopted to further promote the HFA. Kuala Lumpur was selected as the venue for the next conference in 2008.

Given that the International Recovery Platform facilitates cooperation with regional organizations as one of its strategic objectives, it organized a regional forum entitled "Beyond Lessons Learned from Post-Disaster Recovery" on the morning of 8 November. Mr. Reddy of the National Disaster Management Authority of India served as chairperson while Dr. Ian Davis, UK Cranfield University Visiting Professor, served as the panel discussion moderator.

7-3-3. Organizing a Session at the Second Caribbean Conference on Comprehensive Disaster Management

IRP secretariat and CDERA co-organised a session on recovery during the 2nd Caribbean Conference on Comprehensive Disaster Management at Bridgetown, Barbados, 10-14 December. This conference was hosted by the Caribbean Disaster Emergency Response



Agency (CDERA) in association with its partners, including IRP. This IRP Session on Disaster Recovery Planning attracted 145 participants from the governments, UN agencies, and organizations of CDERA participating countries and 7 other countries from the world.

The Conference, bearing the theme "Changing Landscape of Caribbean Disaster Management – Vision Becoming Reality", is a high level forum for assessing the region's progress in disaster risk reduction and charting the way forward in building disaster resilience through



CDM. High ranking Government Officials from CDERA participating states addressed key issues of CDM implementation in relation to the Caribbean Single Market and Economy (CSME), safety and security within a single space in emergency management, and response and disaster management within the national development portfolio. Senior representatives of the donor community as well as other CDM partners and sector leaders spoke to a harmonized programming approach for the advancement of CDM.

The Conference also dwelled on sharing of experiences and good practices in the areas of ICT applications, mitigation and risk transfer applications, and disaster recovery planning. To share good practices and lessons learned on the field of "Disaster"



Recovery Planning", representatives from the IRP Secretariat made presentations.

In the conference recommendations, it was advocated that recovery should be included to disaster legislation for better disaster management in the Caribbean region.

7-3-4. International Recovery Forum – Capacity Development for Better Recovery -

The International Recovery Forum titled 'Capacity Development for Better Recovery' was organized by the IRP Secretariat together with UN/ISDR Hyogo Office and JICA Hyogo—Disaster Reduction Learning Center (DRLC) at JICA Hyogo Center in Kobe, Japan. It was attended by about 200 people.



IRP, following its recently formulated Strategic Framework which highlights the expansion of network, has strengthened partnerships with regional organizations such as SAARC Disaster Management Centre and the CDERA. In the meantime, DRLC was established to promote human resource development in high-risk, low-capacity developing countries. To further enhance the implementation of HFA and stimulate concrete collaboration with and within partners for that purpose, the UN/ISDR Hyogo Office was opened and works closely with the Japanese Government and institutions related to disaster risk reduction as well as institutions in East Asia. In this connection, this forum aimed to further advocate the importance of capacity development for better recovery in the context of mutual cooperation among organizations and to support effective implementation of the HFA.

The forum was opened by the remarks from Mr. Naofumi Taguchi, Deputy Director General for Disaster Management, Cabinet Office of Japan, H.E. Mr. Ryuichiro Yamazaki, Ambassador Extraordinary and Plenipotentiary for Kansai Region, Japan, and Mr. Toshizo Ido, Governor, Hyogo Prefecture. Mr. Sálvano Briceno



delivered the keynote speech "Expectation to Hyogo-further implementation of the HFA". It was followed by four reports on Regional Activities for Capacity Development and Recovery. 7-3-5 Development of a Database on Good Practices & Lessons on Recovery and its Utilization

1) Objective

Various booklets, research reports on good practices, lessons learned, and case studies of major disasters on recovery already exist. These are mostly summarized and analyzed in each major disaster except for some examples. However, when experts on recovery visit disaster affected countries, recovery planners/decision makers from national and local levels frequently asked for "cross-disaster" information on topical thematic lines* which are urgently necessary for for post disaster recovery to realize safer and more secure society.

This project aims to efficiently and quickly provide important on-target information on post-disaster recovery to key persons, who are in-charge of planning and implementing key recovery activities. The project compiles information on recovery through cross-disaster analysis of lessons learned from major disasters.

2) Content

- (1) Collect "Good practices" and "Lessons learned" of post-disaster recovery Collected reports and developed a database on good practices, lessons, case studies mainly on post disaster recovery and provided it on the web
- (2) Publication of guidebook 'Learning from Disaster Recovery'
 IRP Secretariat with the support from ADRC and UN/ISDR produced the book, "Learning from Disaster Recovery Guidance for Decision Makers -" in May 2007.
 The guidebook utilized the disaster recovery case studies collected by IRP. Since its publication, IRP has been distributing this guidebook to related agencies, developing countries, and regions. Likewise, the book is being disseminated during the occasions like organizing and participating events and on mission to overseas.
