# Rationale

More frequent natural disasters with greater magnitude in the last decades

The Great Hanshin earthquake, which occurred in Kobe on 17 January, 1995 & the Great East Japan Earthquake in Tohoku region on 11 Match 2011;

The 2008 Shichuan Earthquake in China; severe flooding in Thailand and Cambodia in the last few years;

Hurricane Sandy, which hit 24 States in the United States of America in October 2012; Typhoon Haiyan in the Philippines in November 2013,

#### **International Responses to Disaster Risk Reduction**

- + The United Nations proclamation of the "International Decade for Natural Disaster Reduction (IDNDR)" in 1990,
- + The "Yokohama World Conference on Natural Disaster Reduction" in 1994,
- + The IDNDR successor "International Strategy for Disaster Reduction (ISDR)" in 2000
- + In January 2005, 168 nations adopted the Hyogo Framework of Action (HFA).
- + The "Hyogo World Conference on Disaster Reduction" in 2005, have ushered a major shift in the understanding and practice of disaster management around the world.
- + The 3rd UN World Conference on Disaster Risk Reduction in March 2015 in Sendai, Japan.

- + Work with and on behalf of most needy groups: the poorest and the most vulnerable.


# **Emergency Relief and Recovery**




# Cambodia Hazard Calendar









#### Overview of Disaster Management in Cambodia





#### **Initiatives and Collaboration**

Summary of DRR Activities of Non-Government Organizations in Cambodia:

Capacity building for NCDM sub-national levels and local structures and local partners to mitigate the risks and address the disasters affecting vulnerable, rural communities, through orientation workshops and relevant trainings on DM/DRR

Support the decentralized structures of NCDM to integrate disaster risk reduction into the national development agenda, and to realize the Hyogo Framework of Action goals; CDP/ CBDRM planning, facilitation in integration of DRR into sub-national and commune development plan, supporting provincial DRR action plans;

Mobilization and training of volunteers, first aid trainings, psychosocial trauma counseling with special focus on women;

Mainstreaming DDR in school curriculum & Disaster risk reduction through school activities

Building community resilience to disasters: Hazard mapping, Flood EWS, Community assessments, participatory vulnerability assessments;

# **Good Practices and Lessons learned**

# Challenges

NCDM Resource Constraints vs NGOs' sufficient resources:

- Capacities of NCDM and the sub-national DM committees in terms of knowledge and skills on disaster management are still limited.
- Limited national budget to support the structure and existing human resources.
- Add-on responsibility officials of the sub-national DM committees
- The sub-national DM committees (PCDM, DCDM & CDDM) are not fully functional and operational.

# Coordination Issues

- NGOs' approaches: project-based, target areas, time frame
- Lack of DM leaderships at the sub-national DM committees
- Lack of coordination among DRR Forum, UNDMT, HANet and JAG
- NCDM's ownership in DRR Forum

# Possible suggestions to enhance the collaboration

- + NCDM Office in charge of NGO liaison and DRR Forum & similar office at PCDM needs to be created.
- + Technical and financial support from donors, DRR networks and NGOs' consortium in creation of NGOs liaison office at the national and sub-national level.
- + Strengthening these existing coordinating networks, rather than creating more networks
- + UNDP, donors and NGOs should continue providing support for creating Disaster Management Information Systems at all provinces in Cambodia and train key PCDM officials to use and maintain DMIS.
- + Expediting enactment of the DM Law to enable NCDM and its sub-national levels to have budget and dedicated staff to implement DM programs and effectively build capacity of the national and sub-national DM committees.
